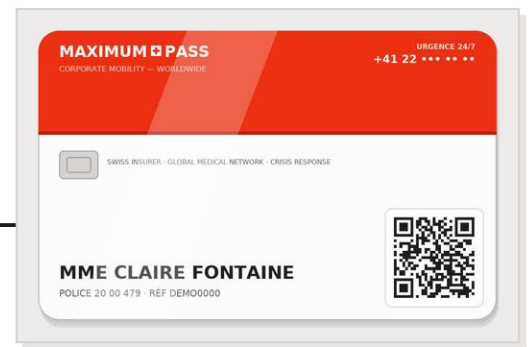

What the policy pays

Three things a bank-card policy does not do.

The hospital is paid without anyone fronting it

The insurer sends its payment guarantee to the facility's finance desk and settles the bill, up to CHF 1.5M. Nobody puts €10,000 on a personal card.

Repatriation has no cap

Unlimited medical evacuation and repatriation, worldwide. The insurer's medical team arranges the transport and picks the receiving facility — nobody improvises at 3 a.m.

One number, and it answers

Medical, security, travel: your employee never wonders who to call, and the hospital desk dials that same number.
