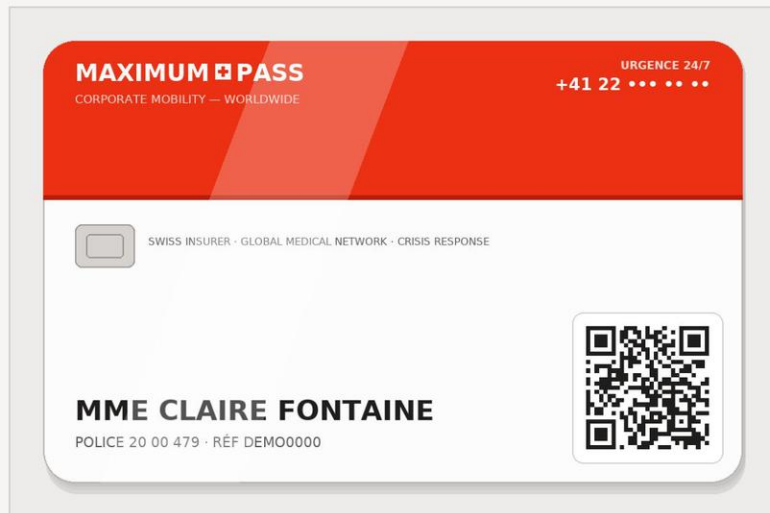

WHAT YOU RECEIVE — ON PAYMENT

- Your named, dated certificate is emailed within thirty seconds, in the format visa applications require, Schengen included.
- Your insured card, with the assistance number and your reference, to put on your phone's home screen.
- Your area: documents, co-insureds, online claim — up to ten named insureds on one policy, each with their own limit.
- One number, answered 24/7, everywhere: the insurer's desk is the one that picks up.

- 207 countries: the official U.S. Department of State advisory level, checked every morning, and the dated feed of every change.

- The observed cost of a medical repatriation, with its source, for the 41 countries where a public source exists.
- The real medical network on the ground and the nearest evacuation point.
- Put your destinations on watch: you are emailed the day one of them changes level.
