**INDIVIDUAL**

### Devis

- You, your collection, your vehicle, your health.
- Estimate or quote, then payment after validation.
- The same 24/7 number as Travel.

**COMPANY**

### Devis

- Seats, fleet, corporate collection, company yacht / jet.
- Quote, certificates — no 1-click until the treaty is live.
- Travel duty of care stays the live company home.

## THE SAME GESTURE AS TRAVEL

- One Pass, one 24/7 number — the card below is the Travel example. Jewelry / Health badges are added when the treaty is wired.
- Documents: table of benefits, wording, sheet, Welcome Kit — uploaded by the insurer.
- Claim: you pick the case. In beta, without a PDF, we open a quote.
- Partner: introductions and white-label, never advice.

- Open /invest and request a TEST quote.
- Share this sheet with an individual, a company, a partner, an insurer.
- Upload insurer PDFs in Hub → Documents. Without them, the page says so.
